

ORDINANCE NO. 7

AN ORDINANCE OF THE TOWN OF PORTAGE, INDIANA,
CREATING AND ESTABLISHING A PLAN COMMISSION
FOR SAID TOWN AND APPOINTING THE MEMBERS THEREOF.

BE IT AND IT IS HEREBY ORDAINED BY THE BOARD OF TRUSTEES OF
THE TOWN OF PORTAGE:

SECTION 1. That there is hereby created and established in
and for the Town of Portage a Plan Commission which shall be known
as the "Portage Town Plan Commission", and which shall have the
authority and be subject to the limitations of Chapter 174 of the
Acts of the General Assembly of the State of Indiana for the year
1947, as now or as may be hereafter amended, repealed or supple-
mented.

SECTION 2. The following people are appointed to the Portage
Town Plan Commission, each for the term set opposite his name:

1. ~~Paul Davis~~ *Harry Sigelson* Until 12:00 o'clock noon
January 1, 1960.
2. ~~Thomas Harris~~ *Joe Mac Murray* ~~So long as he is Town Engineer~~
for the Town of Portage *same*
3. ~~Vernon Reibly~~ *Coatie Wilson* ~~So long as he is Town Marshal~~
of the town of Portage *same*
4. *Darwin Miller* For a term of three years
5. *Peter Nicholson* For a term of three years
6. *Murray Smith* For a term of four years
7. *Edward Quinn* For a term of four years

The terms of the members of said Plan Commission who are not members
of the Town Government shall expire on the 1st day of January of the
third or fourth year, respectively, following their appointment.

THE TOWN OF PORTAGE:

SECTION 1. That there is hereby created and established in and for the Town of Portage a Plan Commission which shall be known as the "Portage Town Plan Commission", and which shall have the authority and be subject to the limitations of Chapter IV of the Acts of the General Assembly of the State of Indiana for the year 1947, as now or as may be hereafter amended, repealed or supplemented.

SECTION 2. The following people are appointed to the Portage Town Plan Commission, each for the term set opposite his name:

- 1. Earl Davis Until 12:00 o'clock noon January 1, 1950.
- 2. Thomas Hanna So long as he is a Town Engineer for the Town of Portage
- 3. Vernon Roffly So long as he is a Town Marshal of the Town of Portage
- 4. Robert Miller For a term of three years
- 5. Peter W. ... For a term of three years
- 6. ... For a term of four years
- 7. ... For a term of four years

The terms of the members of said Plan Commission who are not members of the Town Government shall expire on the last day of January of the third or fourth year, respectively, following their appointment.
