

ORDINANCE NO. 15

AN ORDINANCE APPOINTING MEMBERS TO THE BOARD
OF ZONING APPEALS OF THE TOWN OF PORTAGE.

WHEREAS, By Ordinance No. 14, of the Town of Portage,
Indiana, the Board of Zoning Appeals has been created; and

WHEREAS, The Board of Trustees of the Town of Portage and
the President of the Board of Trustees deems it proper that the
members of such Board of Appeals shall be appointed;

NOW, THEREFORE, BE IT AND IT HEREBY IS ORDAINED BY THE
BOARD OF TRUSTEES OF THE TOWN OF PORTAGE:

SECTION 1. The following people are hereby appointed
to the Board of Zoning Appeals, each for the term set opposite
his name.

1. PETER NICHOLSON UNTIL the 1st day of January, 1960. 1962-1
2. EDWARD DUNN until the 1st day of January, 1961. 1965
3. ROBERT RICKER until the 1st day of January, 1962. 1963-2
4. G. LIMDEN THORN until the 1st day of January, 1963. 1964
5. THOMAS PEARCE until the 1st day of January, 1963. 1965

SECTION 2. Thereafter, as each term expires, each new
appointment shall be for a term of four (4) years.

SECTION 3. The Board of Zoning Appeals shall have all the
powers and be subject to the limitations as outlined and set forth in
Acts of 1947, Chapter 174, as amended or supplemented, now or in the
future.

SECTION 4. This ordinance shall be in full force and effect
from and after its passage.
