

ORDINANCE NO. 68-23

WHEREAS, CERTAIN EXTRAORDINARY EMERGENCIES HAVE DEVELOPED SINCE THE ADOPTION OF THE EXISTING ANNUAL BUDGET, SO THAT IT IS NOW NECESSARY TO APPROPRIATE MORE MONEY THAN WAS APPROPRIATED IN THE ANNUAL BUDGET; NOW, THEREFORE, TO MEET SUCH EXTRAORDINARY EMERGENCIES:

SEC. 1. BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF PORTAGE, PORTER COUNTY, INDIANA, THAT FOR THE EXPENSES OF SAID MUNICIPAL CORPORATION THE FOLLOWING ADDITIONAL SUMS OF MONEY ARE HEREBY APPROPRIATED AND ORDERED SET APART OUT OF THE SEVERAL FUNDS HEREIN NAMED AND FOR THE PURPOSES HEREIN SPECIFIED, SUBJECT TO THE LAWS GOVERNING THE SAME:
