

ORDINANCE NO. 68-30

An Ordinance Amending the "Zoning Ordinance of the City of Portage, Indiana, 1960, Ordinance No. 54

Be it Ordained by the Common Council of the City of Portage, Indiana, under authority of Chapter 174, of Acts of the General Assembly of the State of Indiana, 1947, and all Acts amendatory thereto:

TO AMEND: The following described property, here-to-fer shown in the City of Portage Zoning Ordinance, and the accompanying Maps, as R3, such property to be re-zoned and re-classified, from R3 to C1, --- Lots 2,3,4, and 5, of Deherty's 2nd addition to Garyton, NE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 15, Township 36, Range 7, commonly known as: 2758 & 2762 Willowdale Road, all in the City of Portage, Indiana.

Section 2. Effective Date: This Amendment shall become effective immediately upon its enactment and passage by the Common Council of the City of Portage, Indiana.
